Business case – Norfolk Criminal Justice Board	The Director of Policy and Commissioning in the OPCCN to develop potential options for a Norfolk only Criminal Justice Board.	Work has begun to look at this area in more detail in relation to the Community Safety Partnership for the future. A business case is due to be presented before the 7 <sup>th</sup> May.
Constabulary Tactical Communications Plan - Estates	The Corporate News Manager to send the Constabulary Tactical Communications plans for the purchase of the Hethersett Old Hall School site to the PCC.
