SUBJECT: Ministry of Justice COVID-19 Extraordinary Fund Round 1 – Extension of Delivery Period

## SUMMARY:

This Decision Notice seeks approval from the Police and Crime Commissioner of Norfolk to agree an extension to the delivery period of those providers who have been grant funded under the Ministry of Justice (MoJ) 'Covid-19 Extraordinary Funding Round 1 for Domestic Abuse and Sexual Violence Support Services'. These additional five months, granted by the MoJ, will extend the delivery period until 31<sup>st</sup> March 2021.

All providers funded under the Extraordinary Fund were offered the opportunity to extend their delivery period. Those providers that chose to utilise this extension are detailed below:

- The Change Project
- The One to One Project
- Orwell Housing
- Spurgeons
- Leeway Domestic Abuse and Violence Services

The offer of an extension to the delivery period was provided by the MoJ to enable the original funding to be used over a longer period to more effectively meet the needs of the victims. This funding is vital in supporting providers of domestic abuse and sexual violence services to cope with the short-term disruption, increased demand and incurred additional costs in sustaining their activities due to the effects of the Covid-19 pandemic.

This extension to the delivery period is not accompanied by any additional funding.

**RECOMMENDATION:** It is recommended that the Police and Crime Commissioner for Norfolk approves the extension to the delivery period of those providers who have been grant funded under the Ministry of Justice (MoJ) 'Covid-19 Extraordinary Funding Round 1 for Domestic Abuse and Sexual Violence Support Services' until 31<sup>st</sup> March 2021.

## **DETAIL OF THE SUBMISSION**

## 1. OBJECTIVE:

- 1.1 Measures announced over recent months to tackle coronavirus (COVID-19) have seen people's day-to-day lives drastically altered. These changes have been essential to beat the coronavirus and protect the NHS.
- 1.2 The government acknowledged that the order to stay at home can cause anxiety for those who are experiencing or feel at risk of domestic abuse or sexual violence. There is never an excuse for domestic abuse/sexual violence, no matter what the circumstances are.
- 1.3 In response and to the above and to support victims of domestic abuse and/or sexual violence the Ministry of Justice (MoJ) released a fund known as the COVID-19 Extraordinary Fund which was devolved to Police and Crime Commissioners to administer within their respective areas.
- 1.4 The MoJ have successfully secured agreement to extend the delivery period for this funding until 31<sup>st</sup> March 2021. This will allow providers in receipt of the funding to use it over a longer period of time and more effectively meet the needs of victims.
- 1.5 The funding devolved for Round 1 to the Norfolk Police and Crime Commissioner was a total amount of up to £249,819. This fund was released

and publicised by the Office of the Police and Crime Commissioner for Norfolk (OPCCN) through a variety of digital platforms, forums, boards and groups inviting those organisations that met criteria to bid for funding under the funding streams.

1.6 To be eligible for the funding, organisations had to be a registered charity, a charitable incorporated organisation, or a social enterprise, including companies limited by guarantee and community interest companies. They had to provide support services which have the purpose of helping victims of crime cope with the impacts of crime, and, as far as possible, recover from the harm they have experienced.

## 2 BACKGROUND:

- 2.1 On 2 May 2020, the Government announced a package of £76m extra funding to support victims and survivors of domestic abuse (DA), sexual violence (SV), vulnerable children and their families, as well as victims of modern slavery, during the COVID-19 emergency pandemic.
- 2.2 Of this £76m funding package, £25m will be administered by the Ministry of Justice (MoJ). This is in addition to the £3m per annum (until 2022) funding we are providing to support the recruitment of Independent Sexual Violence Advisers (ISVAs).
- 2.3 The overarching aim is to ensure that the funding is allocated across the sector in England and Wales, reaching support organisations of all sizes and those with the greatest need. We are trying to keep the processes as simple and efficient as possible to ensure that the funding gets to the organisations that need it as quickly as possible. To achieve this, we are, where it exists, using existing funding channels and data on demand and need.
- 2.4 MoJ funding will be distributed via Police and Crime Commissioners (PCCs). The breakdown in the allocation of this funding is shown in the table below. £5m of the funding will also be provided to organisations that are already funded through the national Rape Support Fund (RSF). - 2.5 The details on how the rest of the £76m funding package is being administered and the purpose of each fund is also provided below. Support organisations may find that they need to request funding from more than one fund, depending on the type of provision they require.
- 2.6 The Ministry of Housing, Communities and Local Government (MHCLG) published guidance on 7 May 2020 on how organisations can access the £10m funding allocated for domestic abuse safe accommodation. - 2.7 The Home Office published initial guidance on 19 May 2020, on how organisations could access £2m for domestic abuse. Organisations eligible for the Home Office fund would include:
  - Organisations which provide a national service (i.e. covering all of England and/or Wales).
  - Organisations where the supported victims are very geographically dispersed over multiple PCC areas, and/or no one PCC area is the clear base for the majority of victims.
  - Umbrella or second tier organisations.
  - Organisations which do capacity building, or which support other organisations to support victims and survivors. This includes those supporting the police in their response to domestic abuse. It also includes those supporting local authorities or other statutory bodies.
- 2.8 National Lottery Funding is part of the wider £750m civil society support package that the Government announced on 8 April. In addition to funding being distributed by central Government Departments, part of this package includes an open fund for charities and social enterprises working with vulnerable people affected by the crisis in England. This will be provided through the National Lottery Community Fund.

#### 3 AREAS FOR CONSIDERATION:

3.1 The COVID-19 extraordinary funding is from 24 March to 31 October 2020 to meet the additional costs registered charities or social enterprise have incurred or will incur whilst adapting their services during the pandemic. Some of these organisations were unable to have all services/equipment purchased in place by the initial deadline of 31<sup>st</sup> October 2020. To support these funded organisations the Ministry of Justice extended the deadline for those organisations who were experiencing difficulties to 31<sup>st</sup> March 2021.

## 5 STRATEGIC AIMS/OBJECTIVE SUPPORTED:

5.1 To meet the strategic aim/objective of the COVID-19 Extraordinary fund, funding will support Domestic Abuse and Sexual Violence delivery as follows:

**DA specific funding**, the primary purpose of the organisation's service must be to provide support to female and/or male victims who have experienced DA at any point in their life. This includes adults and children. Funding can be used to support those agencies who have either:

- (a) an existing Grant/Contract with the OPCCN
- (b) does not have an existing Grant/Contract with the OPCCN

**SV specific funding**, the primary purpose of the organisation's service must be to provide support to female and/or male victims who have experienced

rape or sexual abuse at any point in their life. This includes adults and children. The funding can be used to support existing clients as well as new referrals.

### 6 FINANCIAL AND OTHER RESOURCE IMPLICATIONS:

6.1 There are no financial implications for this decision notice. The decision would be to extend the amount of time that providers have to utilise existing funding that was allocated to them under the MoJ Covid-19 Extraordinary Fund Round 1.

## 7 OTHER IMPLICATIONS AND RISKS:

- 7.1 There are no major implications or risks associated with the decision paper.
- 7.2 In line with usual government grants, PCCs must ensure that organisations **do not** use the funding for any of the following activities:
  - campaigning activities (this fund is to support the delivery of direct services for vulnerable people);
  - religious activities outside of projects benefiting the wider community and not containing religious content;
  - political or lobbying activities;
  - loan repayments; or
  - · activities that make profit for private gain
- 7.3 The OPCCN assessed the eligibility of applicants and their applications and the appropriate due diligence checks have been completed.
- 7.4 All organisations awarded funding will need to comply with the 'Check List' that was published when the Extraordinary Grant was released:

- 7.5 The MoJ have also provided information with the Grant Agreement to cross check bids and ensure there is no duplication of ask across different COVID-19 funding streams. The OPCCN has completed this cross check and confirmed to the MoJ that funding offered will not result in duplicate funding.

The government has acknowledged that during coronavirus the order to stay at home caused anxiety for those who are experiencing or feel at risk of domestic abuse or sexual violence. In response to this and to support victims of domestic abuse and/or sexual violence the Ministry of Justice (MoJ) released a fund known as COVID-19 Extraordinary Fund, for the period 24<sup>th</sup> March 2020 and up to the 31<sup>st</sup> Oct 2020, which was devolved to the Police and Crime Commissioners to administer within their respective areas.

Following this first release of Funding came a second wave of funding under the COVID-19 Extraordinary Fund from the Ministry of Justice, known as COVID-19 Round 2.

The Office of the Police and Crime Commissioner for Norfolk, utilising devolved MoJ COVID-19 Round 2 Funding, has extended funding provision to The One to One Project to cover additional staff costs caused by the continuation of the COVID-19 pandemic, the training of volunteers to support the service, mobile phones and additional PPE and cleaning equipment. The One to One Project will ensure the funding is used directly to support this additional need of victims of sexual violence. The value of funding for this extension is £11,000.

The Office of the Police and Crime Commissioner is working directly with front line services to ensure they have an evidence base of need and have the voice of the victim at the very heart of developing additional support.

The Office of the Police and Crime Commissioner is working closely with partner agencies through the County's Domestic Abuse Delivery Group. Membership includes; Norfolk Constabulary, Office of the Police and Crime Commissioner (Chair), Adult Social Services, Children's Services, County Community Safety Partnership, Public Health, District Councils, NHS, and Housing Providers.

# Purpose/key deliverables:

The Recipient shall provide dedicated emotional and practical support services for victims of crime (as defined in Article 2(1)(a) of the Victims' Directive, but restricted to victims of domestic abuse and their families - to help them cope and, as far as possible recover from the effects of crime.

The grant was awarded for meeting essential staffing costs to support additional demand of service, training of volunteers, mobile phones, additional PPE and cleaning equipment.

The government has acknowledged that during coronavirus the order to stay at home caused anxiety for those who are experiencing or feel at risk of domestic abuse or sexual violence. In response to this and to support victims of domestic abuse and/or sexual violence the Ministry of Justice (MoJ) released a fund known as COVID-19 Extraordinary Fund, for the period 24<sup>th</sup> March 2020 and up to the 31<sup>st</sup> Oct 2020, which was devolved to the Police and Crime Commissioners to administer within their respective areas.

The Office of the Police and Crime Commissioner for Norfolk, utilising devolved MoJ COVID-19 Extraordinary Funding, awarded a grant to Leeway for £31,057 for additional technology to enable staff to work flexibly as per government guidelines and to provide Personal Protective Equipment (PPE) to ensure that staff are able to support service users safely during the pandemic.

At the end of their delivery period Leeway reported a £689 underspend due to having procured more cost-effective hardware than was projected in their original bid. The MoJ have agreed that this underspend may be repurposed and instead utilised for additional PPE. This will allow Leeway to continue accessing those domestic abuse victims who required face-to-face support in a safe and effective way.
