## **REASON FOR SUBMISSION: For Decision**

SUBMITTED TO: Police and Crime Commissioner for Norfolk

#### SUBJECT: Extension of Grant for:

Spurgeons – Childrens' Charity to deliver: Norwich Connect

## SUMMARY:

Norfolk Beacon site is part of an innovative partnership between the National Domestic Abuse Charity; Safelives and other local statutory partners, including the Office of the Police and Crime Commissioner Norfolk (OPCCN).

As part of this Beacon Site, a pilot project; Norwich Connect was created to test innovate approaches to domestic abuse. The pilot began in 2018 and was due to run for 3 years.

Spurgeons delivered the Norwich Connect service to offer whole family domestic abuse support:

- Victims who were deemed to be at medium risk of harm
- support for victims who are seen to have complex needs
- Support for people who want to stay with the perpetrator
- Support for children through age appropriate interventions
- Support for perpetrators (where appropriate)
- Training and upskilling professionals in Norfolk to be able to recognise domestic abuse and to know how to respond.

Norwich Connect pilot was due to come to end in June 2021 and no further funding was secured to continue the service. During exit planning of the service, there was a volume of people still in service who required on going support. Other domestic

abuse service providers in Norfolk were unable to offer support to Connect clients due to:

- Services were at their capacity
- There were no 'like for like' services in Norfolk for Connect clients to transition into to safely continue their support.

To ensure the continuous safety for victims in service, some of the existing funding partners, agreed to continue to fund the service until the new OPCCN led, Norfolk Integrated Domestic Abuse Service (NIDAS) was operational in January 2022. The extension would allow for a planned exit strategy to ensure any Norwich Connect clients could safely exit the service.

## **RECOMMENDATION:**

It is recommended the PCC for Norfolk agrees to the funding extension from  $1^{st}$  July 2021 –  $2^{nd}$  January 2022 for the amount of £18,000

## DETAIL OF THE SUBMISSION

## 1. OBJECTIVE:

1.1 To provide an extension of funding to extend the service.

### 2. BACKGROUND:

2.1 In 2016 the Norfolk Community Safety Partnership, supported locally by four main funding partners, agreed to become a 'Safelives Beacon site' and implement and test new approaches to addressing the gaps in UK's response to domestic abuse.

2.2 The project was evaluated by University of Central Lancashire as part of the overall Beacon site. The learning from this pilot has assisting in shaping the new OPCCN led domestic abuse service; Norfolk Integrated Domestic Abuse Service (NIDAS).

2.3 The project pilot came to an end June 2021 as Safelives were unable to secure further funding.

### 3. AREAS FOR CONSIDERATION:

3.1 The funding partners who have agreed to fund this extension are Norwich City Council, Public Health, Childrens Services and Adults Services. Childrens Services have agreed to take responsibility for the commissioning of the extension of Norwich Connect on behalf of the funders and will be managing the Connect Board from 31<sup>st</sup> June 2021.

3.2 There is an understanding the services which were offered during the pilot of the project will be 'slimmed down' during the time of the extension. This is will be part of the strategic, safe exit planning created and executed by Spurgeons which is agreed and monitored by the Connect Board.

#### 4. OTHER OPTIONS CONSIDERED:

4.1 To not fund the extension of the pilot. This option was rejected by the partners as this would leave victims/survivors with a gap in service provision.

## 5. STRATEGIC AIMS/OBJECTIVE SUPPORTED:

5.1 Although Norfolk County Council (Childrens Services) are the lead commissioners for Norwich Connect, the overarching strategy aims are to victim services and are underpinned by statutory legislation that drives commissioning of victims' services across the Local Authority and Police Force areas are:

- Crime and Disorder Act 1998
- Domestic Violence, Crime and Victims Act 2004

- Health and Social Care Act 2012
- Public Services (Social Value) Act 2012

- Directive of 2012/29/EU of the European Parliament establishing minimum standards on the rights, support and protection of victims of crime
- DA Act (2021)
- VAWG Strategy (2021)

## 6. FINANCIAL AND OTHER RESOURCE IMPLICATIONS:

6.1 The overall budget for Norwich Connect pilot (2017-2021) was £832, 998. The overall contribution from the OPCCN was: £133,784.

6.2 The original commitment to fund this pilot was set out in the Police and Crime Plan 2016-20 and integrated commissioning strategy and the costs were contained within the OPCCN Commissioning budget.
