## **Terms of Reference**

- Ensuring that the requirements of the Accounts and Audit Regulation 2011 are complied with, specifically.
- That the system of internal control is reviewed, and an Annual Governance Statement prepared.
- Monitoring the implementation of agreed action plans to address weakness in systems of governance or control.
- Review and monitor compliance with the Scheme of Governance and Consent including the financial regulations.
- Engaging with the Audit Committee as appropriate.
