

# Subject: Transfer of funds held by O P C C N / Norfolk Constabulary on behalf of the Norfolk Resilience Forum to Norfolk County Council

## **Summary:**

Norfolk Constabulary have managed the Norfolk Resilience Forum (NRF) budget on behalf of the partnership since 2010. During the 29th of November 2022 meeting, the NRF Executive Board chaired by DCC Simon Megicks, endorsed a recommendation to transfer the totality of the funds and the budget owner to Norfolk County Council.

The rationale for this decision is to ensure that the funding process can be streamlined, and to remove the duplicate invoicing and reporting currently taking place by Norfolk County Council who also manage a small NRF budget.

The value of the funds to be transferred is £470,410.04 (NRF General £156,965.87 plus NRF DLUHC £313,444.17)

## Recommendation:

The recommendation is to endorse the decision made by the NRF Executive Board held on 29th November 2022 and to transfer the funds to Norfolk County Council.

## Detail of the submission

## 1. Objective:

To streamline the Norfolk Resilience Forum funding process and to remove duplicate invoicing and reporting currently taking place by Norfolk County Council. The decision will also remove invoicing between Norfolk County Council and Norfolk Constabulary.

## 2. Background:

Norfolk Constabulary have managed the Norfolk Resilience Forum (NRF) budget on behalf of the partnership since 2010.

The process for recharging costs is currently convoluted. Norfolk Constabulary invoice the NRF partners for their annual contribution to the overall NRF cost. The NRF project staff are employed by Norfolk County Council (NCC) who in turn must invoice Norfolk Constabulary back for the staffing expenditure.

Additionally, once the funds are transferred back to NCC there will not be the need for NCC staff to have access to the constabularies Oracle E-Business Suite (EBS) in order to place purchase orders and this will help reduce the overall licence requirement.

At the NRF meeting on 29th November 2022, the NRF Executive Board chaired by DCC Simon Megicks, endorsed a recommendation to transfer the totality of the funds and the budget owner to NCC to improve the value for money arrangements.

## 3. Areas for consideration:

Value of the financial funds to be £470,410.04 (NRF General £156,965.87 plus NRF DLUHC £313,444.17).

## 4. Other options considered:

Consideration has been given to retaining the funds within PCC bank accounts and the management and administration through the constabulary. However, this would maintain the inefficiency and duplication of processes across the constabulary and Norfolk County Council.

# 5. Strategic aims/objective supported:

Indirectly this transfer helps Support Norfolk Constabulary by removing an inefficient management of NRF Funds back to the County Council streamlining the process and removing the administrative burden from the constabulary.

## 6. Financial and other resource implications:

The treasury management team of O P C C N / Norfolk Constabulary have been made aware that a transfer of funds will be needed upon the agreement of this document.
