Summary:

- 1. The Safer Norfolk Plan is the Norfolk Community Safety Partnership's plan to respond to community safety issues in Norfolk. It identified neighbourhood crime, including anti-social behaviour (ASB), as a priority for the county. It acknowledges the impact of ASB on feelings of safety within the community.
- 2. The delivery of this ambitious plan across all seven districts in the county will be supported by a £500k budget. This funding is being provided by the Office of the Police and Crime Commissioner for Norfolk to facilitate delivery against this plan. The members of the NCCSP will work collaboratively to utilise existing resources and bring in extra funding to support the aims of the strategy.
- 3. A key principle within the public health model is testing interventions and then scaling up those which are effective. Much of the response to ASB is reactive when certain thresholds are met. South Norfolk and Broadland District Councils wanted to test responding to ASB complaints earlier and how it will impact complainant satisfaction and levels of ASB in the localities. This funding is provided to test this intervention approach and measure its impact. It will enable employment of an Early Intervention ASB Officer, covering both council areas. The deliverables are set out in greater detail in section 1.

Recommendation:

It is recommended that the Police and Crime Commissioner grant funds South Norfolk and Broadland Councils £31,500 to enable testing of the Early Intervention ASB Officer model.

Detail of the submission

1. Objective:

- 1.1 The Early Intervention Anti-Social Behaviour Officer pilot service will employ an Early Intervention Anti-Social Behaviour Officer from April 2023 to March 2024, work individually and alongside a range of professional officers, to:
 - a. Gather more early intelligence, identify and tackle root causes of anti-social behaviour in the Councils' Regulatory services, in order to produce long-term improvements in neighbour relations and community safety.
 - b. Increase the capacity and drive, speed and impact, of the Councils' service by taking an early intervention approach to anti-social behaviour and environmental offending.
 - c. Offer stronger visibility and community reassurance.
 - d. Detect better and earlier any wider victimisation, vulnerability and support needs, and safeguarding issues.
 - e. Optimise the deterrence, investigation and enforcement of anti-social behaviour (within the Council's remit) where offences have been committed causing harassment, alarm, distress or environmental harm.
 - f. Test the scope for stronger coordination of responses and tactics for dealing with significant ongoing anti-social behaviour issues and incidents, operating (within the Councils' remit) closely alongside Norfolk Constabulary as a key regulatory partner.

2. Background:

- 2.1 Nationally, the government has developed the ASB Action Plan, which identifies prevention and early intervention as an area for action. It highlights how if low level offending is left unchecked, it can escalate into more serious behaviours, causing further harm to communities.
- 2.2 The Safer Norfolk Plan is the Norfolk Community Safety Partnership's plan to respond to community safety issues in Norfolk. It identified neighbourhood crime, including anti-social behaviour (ASB), as a priority for the county. It acknowledges the impact of ASB on feelings of safety within the community.
- 2.3 The plan states local residents want to live without fear of being the victim of crime in their neighbourhood. Some neighbourhoods are more affected by

- neighbourhood crimes than others. The partnership will work together to tackle neighbourhood crime in these areas.
- 2.4 The delivery of this ambitious plan across all seven districts in the county will be supported by a £500k budget. This funding is being provided by the Office of the Police and Crime Commissioner for Norfolk to facilitate delivery against this plan. The members of the NCCSP will work collaboratively to utilise existing resources and bring in extra funding to support the aims of the strategy.
- 2.5 The NCCSP will strengthen its response to community safety locally. To do this it will deliver its plan using an evidence led approach, with the Public Health Model of prevention at its heart.
- 2.6 A key principle within the public health model is testing interventions and then scaling up those which are effective. South Norfolk and Broadland District Councils wanted to test responding to ASB complaints earlier and how it will impact complainant satisfaction and levels of ASB in the localities. This funding is provided to test this intervention approach and measure its impact. It will enable employment of an Early Intervention ASB Officer, covering both council areas. The deliverables are set out in greater detail in section 1.
- 2.7 The Early Intervention Anti-Social Behaviour Officer pilot was designed to offer an inexpensive and beneficial extension of the existing Community Protection service which deals with neighbour nuisance, anti-social behaviour and environmental offending.
- 2.8 The pilot service is offered:
 - 1. In qualifying cases for reported anti-social behaviour and neighbour problems that meet the Council's threshold acceptance tests:
 - 1. The reported problem is within the Council's jurisdiction as the lead agency.
 - It is potentially significant and actionable.
 - 3. There is no prior history of complaint or enforcement.
 - 4. When an early intervention service approach is offered, the customer actively chooses it.
 - 2. In cases of reported environmental offending, where a rapid response offers community visibility and reassurance, and optimises evidence gathering.
 - 3. In 'patrol mode' to keep an eye proactively on hot spot locations of reported fly tipping or dog fouling, to maximise detection and dealing with suspected offenders.

- 4. In tactical coordinated responses to significant incidents such as vehicle-related nuisance.
- 2.9 The Council's Community Protection service has been under heavy demand and a substantial increase in service demand across both South Norfolk and Broadland districts. Some of this in 2020/21 (40% rise in demand) and 2021/22 (39% rise in demand) was due to the special circumstances arising during the Covid-19 pandemic. There was, however, a continuing high service demand in 2022/23 running over 8% above previous annual levels and in the service's peak demand month of August last year demand was running 70% higher than it did four years ago.
- 2.10 The pilot service corresponds with the Council's strategic aims for 'Supporting individuals and empowering communities' and 'Protecting and improving the natural and built environment, whilst maximising quality of life'. In the Delivery Plan 2022/23 2023/24 it forms the specific commitment Q1: 'Robust and dynamic antisocial behaviour rapid response and early intervention service to maximise community safety and public reassurance' with the intended outcomes:
 - Swift response
 - 2. Rapid solution
 - 3. High impact
 - 4. Low re-occurrence

3. Areas for consideration:

- 3.1 The funding utilised for this intervention comes from OPCCN budget that is dedicated to delivering the Safer Norfolk Plan.
- 3.2 This funding is agreed to be one-off funding to pilot an approach for the financial year 2023/24.

4. Other options considered:

- 4.1 Do nothing: this innovative intervention would not be tested, depriving the Community Safety Partnership of valuable learning.
- 4.2 Funding this innovative project is the preferred option as it will provide valuable learning.
- 5. Strategic aims/objective supported:
- 5.1 The Police, Crime and Community Safety Plan is supported by this intervention:

a. Prevent Offending

- Work in partnership to ensure offenders are managed effectively in the community
- ii. Strengthen early intervention and preventative approaches to crime in the county and reduce first time entrants into criminal justice

b. Support Victims

- i. Safeguarding vulnerable victims of crime and ASB
- c. Safer and Stronger Communities
 - i. Working with partners and communities to prevent crime and harm
 - ii. Early identification and diversion to the appropriate agencies for those suffering with mental health issues
 - iii. Promote crime prevention initiatives
- 5.2 This intervention directly contributes to the delivery of the Safer Norfolk Plan by delivering on the strategic theme of Tackling and Reducing Neighbourhood Crime:
 - a. Short-term outcomes:
 - i. Improve partnership place-based understanding of neighbourhood crime to enable the better targeting of Norfolk's hotspots
 - b. Intermediate outcomes:
 - i. Preventative, supportive and rehabilitative interventions in place at primary, secondary, and tertiary population levels
- 6. Financial and other resource implications:
- 6.1 To deliver the intervention the OPCCN will grant fund South Norfolk and Broadland councils a total of £31,500 in the Financial year 2023/24
