RE: Freedom of Information Request FOI/OPCCN/250

I am writing in connection with your email dated 25 February 2025, in which you requested the following information:

Safer Streets Funding Allocations and Impact

Please provide information on the allocation of Safer Streets funding from the Home Office to the Office of the Police and Crime Commissioner for Norfolk (OPCCN) over the past five years, including:

- Annual funding amounts received from the Safer Streets scheme.
- A breakdown of how these funds have been allocated (e.g., community safety initiatives, CCTV expansion, street lighting improvements, youth intervention programs).
- Any notable projects or initiatives that have been funded and their reported outcomes.
- Changes in funding levels year-on-year and any consequences of increased or reduced funding.

I have reviewed our records and can advise the following:

The OPCCN was awarded funding from the Home Office's Safer Streets Fund on three occasions over the past five years. On two occasions, the OPCCN did not bid for Home Office Safer Streets Funding, but Norwich City Council and Great Yarmouth Borough Council did and were awarded funds.

Annual fund amounts received is publicly available via our decision notices on our website. You can find them here:

- Safer Streets Fund Round 1 (awarded 2020). Original decision notice is confidential because it talks about locations vulnerable to burglary – however this press release covers the initial award: <u>Initiative to reduce burglaries and thefts in Norwich welcomed</u> <u>by PCC and partners | Norfolk PCC</u>. During this round of funding, Norfolk OPCC were awarded additional funding covered in <u>Decision-Notice-01-2021-Safer-Streets-Fund-Great-Yarmouth.pdf</u>

Please be aware that a press release for the Safer Streets Fund Round 5 is in development and will be available in the near future. It will utilise final outcome reporting, which will not be available until late April 2025.

In regards to changes in funding levels, Safer Streets funding has been provided via grants. The OPCCN were granted money to deliver specific interventions over a set time and it was clearly communicated that the Home Office would not provide funding for continuity of these interventions beyond the end of each grant round. Therefore, there was a limited consequence of the changing sizes of grant awarded to the OPCCN. However, in Safer Streets Fund Round 5, the original 'award' was reduced for the second financial year by £180,000, which resulted in the cancelling and scaling of planned intervention. The specifics of this are details in the relevant decision notices.

Internal Review

If you think we have not supplied information in accordance with Section 1 (the General Right of Access) of the Freedom of Information Act 2000, or you are dissatisfied with the way in which your request has been handled, then you should write within 40 days of the date of the response to:

If you are dissatisfied in any way with our response or the way we have handled your request, you can contact us by phone, email or in writing. We may, in the first instance, try and resolve your complaint informally. However, at any stage you can request, or we may decide to treat your complaint formally under our internal review process.

An internal review is conducted by the Chief Executive who will review the request and response, taking account of your complaint(s), and will respond in writing as soon as possible. The Information Commissioner's Office recommends that a response should be made in 20 working days. If we are unable to respond in this timeframe, we will inform you and provide a date by which you should expect to receive our response.
