

# Subject: Brave Futures Grant Extension

Summary:

- 1. Brave Futures are commissioned by the Office of the Police and Crime Commissioner to provide intensive support to children aged 11-18 years and who are victims of child sexual abuse.
- 2. This commissioned service complements the support in place commissioned by the Great Yarmouth & Waveney Integrated Care Board (ICB) who are lead commissioner for commissioning support for children who have been sexually abused between 0-11yrs.
- 3. This Decision Notice is to extend the service from 1<sup>st</sup> October 2025 to 31<sup>st</sup> May 2026.

### **Recommendation:**

That the PCC supports this decision to extend funding to Brave Futures for period  $1^{st}$  October  $25 - 31^{st}$  May 2026.

# 1. Objective:

- 1.1 To provide intensive specialist support to children aged 11-18 years who are victims of child sexual abuse across Norfolk.
- 1.2 The service will give children and young people the skills and tools they need to rebuild their futures, manage trauma they have experienced and help them move from victim to survivor.

# 2. Background:

- 2.1 The Norfolk PCC has previously commissioned Brave Futures to provide specialist services that support children aged 11-18 years who have experienced sexual abuse and their families up to 30 September 2025. This arrangement is by way of a Grant Agreement.
- 2.2 The OPCCN is currently completing a review of support provision for victims of sexual violence and abuse in Norfolk. Pending decisions on future services there is a need to extend existing service provision so that the needs of victims continue to be met.
- 2.3 The funding under the Grant Agreement will be extended to 31<sup>st</sup> May 2026 the terms and conditions of the Grant will remain the same.

### 3. Areas for consideration:

- 3.1 The funding of this service aligns with specialist sexual violence services currently commissioned by the OPCCN, those being the Sue Lambert Trust, the Rowan Project delivered by the Daisy Programme and the Lotus Programme delivered by One-to-One Counselling Service.
- 3.2 This extension will allow for completion of the review of current sexual violence support services in Norfolk.

### 4. Other options considered:

4.1 Not to fund this service – this option was rejected as it would leave children and young people aged 11-18 years with extremely limited provision for specialist intensive work and therapeutic programmes to help those affected by child sexual abuse, to cope and recover from the crimes that have been committed against them.

#### 5. Strategic aims/objective supported:

- 5.1 The PCC has a statutory obligation to set out Police and Crime objectives through the Police and Crime Plan 2025-29. The PCC's priorities are

  - Cohesive communities
  - Reducing harm
- 5.2 This grant will support the pillar Reducing harm
- 5.3 The primary statutory legislation that drives the commissioning of domestic abuse services across the Local Authority and Police force areas are:
  - Crime and Disorder Act 1998
  - Domestic Violence Crime and Victims Act 2004
  - Children Act 1989 and 2004
  - Health and Social Care Act 2012
  - Public Services (Social Value) Act 2012
  - Equality Act 2010
  - Directive 2012/29/EU of the European Parliament establishing minimum standards on the rights, support and protection of victims of crime Directive 2012/29/EU
  - Code of Practice for Victims of Crime MOJ Victims Code 2020
  - Home Office Tackling Violence Against Women and Girls Strategy
  - Domestic Abuse Act 2021.
- 5.4 Quality standards that will be supported are set out in the following documents:
  - NICE Guidance on Child Abuse and Neglect (<u>https://www.nice.org.uk/guidance/ng76</u>), which makes recommendations for a range of therapeutic interventions for children, young people and families after sexual abuse
  - The Norfolk Sexual Violence Strategy produced by the County's Community Safety Partnership (CCSP) that support the work of the Domestic Abuse and Sexual Violence Group (DASVG)
- 6. Financial and other resource implications:

- 6.1 The total grant funding will be £58,666 (fifty-eight thousand six hundred and sixty six pounds) for the 8 month period 1st October 2025 to 31<sup>st</sup> May 2026.
- 6.2 The funding will come from the Commissioning Reserves Budget.
